GENERAL INFORMATION

K GRO is a blend of potassium and crop enhancement components. **K GRO** is designed for use on all crops and may be used for foliar or soil applications. **K GRO** is intended to be used as a supplement to a standard fertility program.

GENERAL APPLICATION RECOMMENDATIONS

Foliar Applied

Apply 1-4 quarts/acre prior to the occurrence of nutrient deficiency symptoms. For ground applications use a water carrier volume of 10 GPA minimum or 5 GPA for aerial applications. Multiple applications may be used as needed. **K GRO** may be tank mixed with pesticide applications.

In-Furrow

Apply 1-2 quarts/acre at planting.

2x2, Soil Broadcast, Side-Dress

Apply 1-12 quarts/acre for applications made directly to the soil.

TANK MIXING INSTRUCTIONS

Dilute **K GRO** with water before adding pesticides or other nutrients. Always perform compatibility or jar test with tank mix components before mixing in large quantities.
