**DIRECTIONS FOR USE**

(Mix well before using)

**USE RATES**

**Ground:** 10 – 12 ounces/acre when applied at a carrier volume up to 12 gallons per acre spray solution. Use 12 ounces/acre rate when carrier volume is greater than 12 gallons per acre spray solution.

**Aerial:** For 5 gallons per acre spray solution application rate or less, apply at 1% volume/volume.

**MIXING INSTRUCTIONS**

Always add **PLEXUS II** last to the spray mix and continue agitation, unless directed otherwise by the specific pesticide label. Always follow the label of the specific pesticide for detailed adjuvant use directions.

A nitrogen source may be added to **PLEXUS II** when required or suggested by the pesticide label.

**STORAGE & DISPOSAL**

Store product in original container, tightly closed in a dry and well-ventilated area. Do not store near heat or open flame. Do not reuse container. Do not contaminate water, food or feed by storage or disposal. Keep packaging closed, securely fastened and upright. Product may suspend in layers if stored below 45°F.

Triple rinse (or equivalent) prior to disposal. Add rinsate to spray tank. Offer container for recycling or dispose of properly in accordance with all applicable regulations. If burned, stay out of smoke.

**FIRST AID**

**EYE EXPOSURE:**

- Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. If irritation persists get medical attention.

- Wash with plenty of water for at least 15 minutes. If irritation occurs get medical attention. Take off contaminated clothing and wash it before reuse.
